Warrants that Designer Beadcrete® and Designer Concrete Pool Render products manufactured by Designer Concrete Coatings Pty Ltd are good and fit for their intended purpose conforming to relevant Standards Australia/New Zealand Test Methods and compliance with the Trade Practices Act (Commonwealth) and shall be free of manufacturing faults and/or defective materials at the point of sale.

If for a limited period of seven (7) years from the completion date of installation of Designer Beadcrete® or Designer Pool Render on a normal residential concrete pool shell the Product is proven to be faulty or defective as a direct result of manufacturing processes or raw materials it shall be repaired or replaced at the discretion of Designer Concrete Coatings Pty Ltd.

This limited warranty explicitly excludes colour variation in the finished work from selected display samples, failure or damage resulting from improper workmanship or failure from neglect to fill the pool with water immediately upon completion of the work or use of any other installation methods not recommended by Designer Concrete Coatings Pty Ltd which are the responsibility of the independent entity contracted to complete the works, abuse of pool owners' normal maintenance requirements and neglect of proper and regular water chemical balance, the construct of any supporting concrete pool shell substrate, using the pool for any other purpose than for human swimming activities, damage, discolouration, stains, algae growth or subsistence of any other foreign matter caused by external agents or materials, damage resulting from alterations or repairs or incorrectly draining and refilling pool water, accident, defective sub-grades, movement of the sub-base/ground, concrete cracking, flood, earthquake or other act of God, or the performance of any other materials used in conjunction with Designer Beadcrete® or Designer Pool Render products for which no guarantee is or can be given.

The completion date of the work and proof of product purchase and product payment must be documented by the independent entity contracted to do the work and the pool owner on the form below and returned to Designer Concrete Coatings Pty Ltd within 30 days after completion of the work for any warranty claim to be considered.

This warranty is between Designer Concrete Coatings Pty Ltd and the pool owner conditional upon full payment for the work and is not transferable to any other party and is strictly limited to whole use of Designer Beadcrete® or Designer Pool Render products manufactured by Designer Concrete Coatings Pty Ltd for the performance of the work. Use of substitute materials in whole or in part will void this warranty.
